

Rain Barrel Reimbursement Form

Am I eligible to apply for reimbursement?

The Madison Area Municipal Stormwater Partnership (MAMSWaP) is offering a \$30 reimbursement for anyone who purchased and installed a rain barrel through Dane County in 2022. You are eligible to apply if you meet the following:

- I purchased a rain barrel through Dane County in 2022.
- The property where the rain barrel was installed is located within a MAMSWaP Community (see list of communities on the second page of this form).
- I installed the rain barrel on a downspout and applied for reimbursement within 3 months from the date of purchase.

Instructions

- Step 1. Fill out your information on the form below.
- Step 2. Mail or email (guy.claudia@countyofdane.com) the following items to Dane County LWRD; Attention: Claudia Guy; 5201 Fen Oak Dr.; Madison, WI 53718:
- This form,
 - A photo showing where the rain barrel was installed, and
 - A copy of your order receipt.*
- Step 3. Within 10 business days, you will receive an email confirming receipt of the application. If no additional information is needed, you will receive an email confirming your reimbursement. The reimbursement will be processed to the credit card that was used to purchase the rain barrel.

Please include the name on the credit card which made the purchase, as well as an approximate date of purchase.
