Rain Barrel Sale Summary- The rain barrel order system is closed for the year and will open again in late April 2025.

- A record # of rain barrels (735) sold in 2024, a 25% increase from 2023.
- 237 MAMSWaP residents requested reimbursements for 318 rain barrels in 2024.
- \$9,540 issued to member residents as part of rain barrel reimbursement program in 2024.

<u>Adopt A Storm Drain Update-</u> Since relaunching in early 2024 the online Adopt A Storm Drain application has been working well with significantly less user issues reported.

- 116 total number of adopters
- 245 drains adopted
- 660 cleanings logged

<u>2024 MAMSWaP Stormwater Outreach/Ed. Survey</u>- We received 359 mailed responses from the 1500 surveys that were randomly mailed to MAMSWaP community residents, 24% response rate. 185 online surveys (fully completed) were submitted. The link to the separate online survey was sent to municipal and local partner groups with a request to share with their residents and members and also promoted via the Ripple Effects FB page. Survey results will be shared at the Nov. MAMSWaP meeting. The final report will be shared in late Dec. 2024.

<u>2025 MAMSWaP Clean Sweep Events</u>- Four MAMSWaP Clean Sweep are scheduled for this spring. Partnering municipalities are assigned a week during which residents who register can dispose of household hazardous waste for a reduced cost (\$5). Residents must use the voucher during open business hours of the assigned week. Each community will be limited to 100-125 vouchers and the cost will be evenly split between MAMSWaP, the participating municipality, and the resident each paying \$5 per voucher that is redeemed during the event. 2025 Clean Sweep Event Schedule:

- March 25-29- Stoughton Event
- March 31-April 5- Town of Middleton Event
- April 7-12- Windsor Event
- April 14-19- Monona Event

<u>Partner Check-In Meetings</u>- Claudia and Christal met with fifteen of the twenty MAMSWaP communities this summer. Feedback on current efforts and needs for the future was collected and used to develop the 5-year I&E Plan.
